Each lighting installation is subject to full compliance with Electrical Codes, and following the Electrical Code regulations is mandatory.

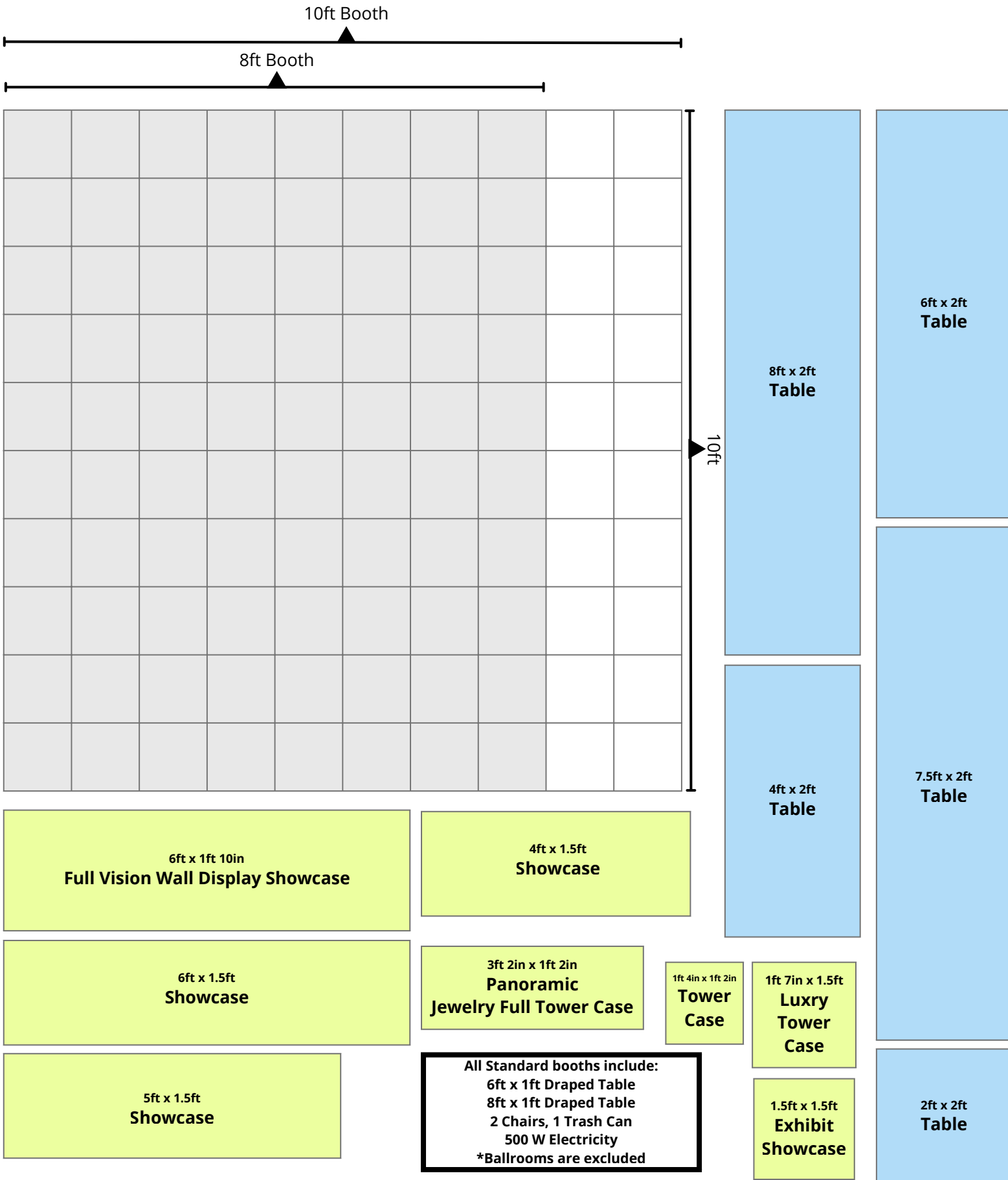
